CBDRG, established in 2015, is a network of business, non-profit, faith-based and government organizations partnering to support long-term disaster recovery efforts in the 11 county region of the Coastal Bend.

CBDRG aids disaster survivors with long-term recovery by providing case management services, construction or home repair assistance, volunteer and household donations coordination, and spiritual/emotional care.

To strengthen regional long-term recovery by addressing and jointly resolving unmet, disaster-related needs of individuals in the community.

Hurricane Harvey

On Aug. 25, 2017, Hurricane Harvey made landfall in the Coastal Bend area of South Texas. The storm came ashore near Rockport as a Category 4 hurricane with winds up to 152 mph and a storm surge up to 10-feet. Hurricane Harvey damaged 40,929 structures, and \$4.5 Billion in damages to the Coastal Bend. Over 86,000 applied for FEMA. The need for help was obvious and CBDRG answered the call to the vulnerable survivors.



What is an Unmet Need?

An Unmet Need is a basic (safe, sanitary & functional) need that is **disaster related** and the survivor is unable to obtain because they lack either part or all of the resources to obtain that need.

When Do We Respond?

Disaster Recovery Group activates when there is a **Federally Declared Disaster** and **Individual Assistance** has been approved.

Who Receives Assistance From CBDRG?

Our clients include homeowners who are considered low income or socially vulnerable (elderly, single head of household with minor children, disabled, honorably discharged US Veterans). CBDRG, through Case Management, helps the client develop a recovery plan, and organizes the volunteers, materials and supplies to assist them in restoring their home.

Hurricane Harvey Volunteer Achievement:

179,000 Volunteer Hours \$3.4 Million in Construction Cost Savings

90% of skilled volunteer hours coming from NVOAD members




Coastal Bend Disaster Recovery Group August 2017 - March 2023

Tierra de Esperanza, or "Land of Hope," is a 23 home community in the small town of Woodsboro, Texas. It is a partnership between Coastal Bend Disaster Recovery Group, Mennonite Disaster Service (MDS), Disaster Aid Ohio, Catholic Charities of Corpus Christi, Rebuild Texas, Presbyterian Disaster Assistance, The Community Foundation of Middle Tennessee, Week of Compassion, and the town of Woodsboro.

- CBDRG purchased the **3.6** aces of land for the 23 homes and provided Case Management.
- MDS & Disaster Aid Ohio provided the 30,000 volunteer hours to build the homes.
- Catholic Charities of Corpus Christi provided funding and a base camp for the volunteers at Our Lady of Refuge Catholic Church in Refugio, TX.
- Town of Woodsboro provided sewer and water lines, culverts and waived tap fees.
- 8/20/2020 Land Purchased
- 9/23/2020 Groundbreaking Ceremony
- 3/25/2021 1st Home Giveaway (13 Homes on Celia St)
- 5/20/2021 2nd & Final Giveaway (10 Homes on Pugh St)
- 9 months from groundbreaking to completion


